### **Community Center**

**Treasurer's Report**: Treasurer Carolyn LaRue read the treasurer's report. Sherry Simms-Fleming made a motion to approve. Amelia Salazar seconded. Motion approved.

**P.V.F.D. Report**: Fire Chief Dennis Massey submitted the Fire Department's budget and report from February. The checking balance of \$12,676.14 is incorrect. Dennis will provide correct figures at the April meeting.

**Old Business:** 

- A. **Mayor's Report**: Mayor Jerry Lane expressed deepest sympathy from the community to board member Sherry Simms-Fleming in the loss of her husband Paul Fleming. Also, the message board at the mailboxes is completed.
